18. Leverage Shareholder Influence – Encourage activist investors to question billionaire backing of Trump at corporate shareholder meetings, forcing transparency and accountability.
19. Use Media & Public Messaging – Craft compelling campaigns highlighting how continued Trump support harms their reputation, brand value, or global standing.
20. Engage Employees – Encourage workers at their companies to organize petitions or walkouts, pushing executives to rethink their political ties.
21. Explore Legislative Pressure – Work with lawmakers to implement tax transparency or policies that make it harder for billionaires to shield political donations in dark money funds.
22. Appeal to Philanthropy – Highlight contradictions between their charitable efforts and their political contributions—especially if they claim to support democracy or social justice.
23. Direct Outreach & Persuasion – Use open letters, ad campaigns, or direct conversations to appeal to their sense of legacy, urging them to take a stance for democracy.
24. Strategic Legal Challenges – Investigate potential areas where Trump's influence has enabled financial misconduct among his wealthy backers. If a legal route exists, it could create distancing.
25. International Pressure – If they have global interests, leverage international bodies or pressure from allies to highlight reputational damage.
26. Social Pressure Through Local Networks – Encourage community members to engage in conversations about billionaire influence on politics. Small shifts in perception can have ripple effects.
27. Micro-Petitions & Localized Campaigns – Instead of national efforts, target local businesses connected to these billionaires, urging them to reconsider associations.
28. Alternative Support Groups – Connect people with ethical businesses and influencers who oppose Trump, redirecting consumer power toward leaders who align with democratic principles.

29. DIY Public Messaging – Help people create simple, viral content—handwritten signs, creative protest slogans, or budget-friendly flyers to distribute at community events.
30. Influencing Local Leaders – Focus on elected officials, small business owners, or community influencers who might have indirect ties to these billionaires—convincing them to speak out.
31. Low-Cost Digital Advocacy – Organize small, coordinated social media pushes (hashtags, comment campaigns, tagging billionaires in critical posts) without needing paid ads.
32. Creative Street-Level Actions – Use sidewalk chalk, protest art, or guerrilla sticker campaigns in strategic locations to subtly challenge billionaire support.
33. Storytelling & Testimonies – Encourage working-class people affected by Trump's policies to share their experiences—real stories have emotional impact that can shift public narratives.

He briefly served as an adviser in Trump’s White House and as an on-screen political analyst for Sinclair Broadcast Group. was seen walking to a Manhattan courtroom during Donald Trump’s criminal trial on charges of falsifying business records in New York on May 29, 2024. After Trump refused to accept his loss in 2020, Epshteyn worked with former New York City Mayor Rudy Giuliani on efforts to overturn the election results. He was accused of working with Giuliani to submit fake electors for Trump in Arizona and obstruct Congress’s certification of the results. Epshteyn has pleaded not guilty to nine felony charges in Arizona related to the case.

The Silicon Valley venture capitalist and close friend of Musk will serve as Trump's "AI and crypto czar" after fundraising for Trump in San Francisco, boosting the president-elect on his influential All In podcast, and spending election night at Mar-a-Lago.

The UFC kingpin had a prime seat at Trump's inauguration, and he will now serve on Meta's board, likely making him Trump's envoy to the social media giant.

The White House "border czar" is helping to lead Trump and Miller's sweeping mass deportation program, and he's a high-profile defender of the administration's more contentious policies, like the plan to house deportees at Guantanamo Bay.

The White House Chief of Staff led Trump's 2024 campaign and is widely credited with disciplining a chaotic operation. Still, Trump's prior chiefs of staff have struggled to stay employed.

The world's richest man spent over \$200 million to get Trump elected, and his Department of Government Efficiency has exerted vast influence, rapidly slashing agencies like USAID and accessing the government's payment and HR systems. He's also become inseparable from the commander-in-chief—even popping up in Trump family photos at Mar-a-Lago. How long can that last? (Net worth: More than \$400 billion.)

Thiel isn't taking a formal Trump administration job, and he and Trump reportedly had a falling-out over donations in 2023. But his influence over this White House—through all of his connections—should be



massive. (Net worth: \$15.4 billion.)

This billionaire venture capitalist was Trump's biggest Silicon Valley backer in 2016, but more importantly, many of Trump's allies have deep ties to Thiel or are his acolytes. J.D. Vance is a Thiel protégé, and Thiel is close with other Trump associates like Musk and Vivek Ramaswamy.

Thomas F. Gilman served as Assistant Secretary of Commerce for Administration and Chief Financial Officer of the U.S. Department of Commerce in the Trump Administration.

Trump picked him to lead the Office of Management and Budget, a low-profile role that grew even more powerful with Trump's unprecedented attempt to pause many federal grants (which the courts have put on hold).

Trump's Education Secretary nominee co-chaired Trump's transition, and her pro-wrestling DNA (she co-founded the company that became WWE with husband Vince McMahon) pairs well with Trump.

Trump's Middle East envoy is getting a lot of credit for the Israel-Hamas ceasefire—and he's touting Trump's controversial plan for the U.S. to "take over" Gaza. The real estate investor and Trump friend also took center stage on Inauguration Day. (Net worth: At least \$1 billion.)

Trump's pick for FBI director is known for his fierce loyalty. The January 1 New Orleans attack has led some allies to push for his speedy confirmation. He is facing little Senate GOP resistance despite his hardline views, including promoting 2020 election conspiracies and promising to punish Trump's supposed enemies, including those "in the media."

Trump's Secretary of State is a leading Trump Yes Man in early foreign policy moves: USAID's shuttering, the proposed Gaza takeover, a plan to send deportees to El Salvador, and even a longshot push to buy Greenland.

Trump's son-in-law told Forbes he may advise Trump informally, but so far, his influence is not apparent—

though some see his hand in Trump's dream of turning Gaza into the "Riviera of the Middle East." Kushner controversially suggested something like that last year. He advised Lutnick and may assist more with Middle East diplomacy. (Net worth: Just under \$1 billion.)
